1. Veteran Family

Family (with dependent children) in which the head of the household or the spouse of the head of the household is a Veteran or a single Veteran. (Surviving Spouse's are ineligible for assistance).

2. Very Low Income

< 50% of area median income

Your Veteran Status

To receive supportive services under the SSVF program, you must be

- ♦ A veteran (A “veteran” is defined as a person who has served in any branch of the Armed Forces of the United States. You are a “veteran” even if you were never stationed in a combat zone, and regardless of your discharge status. However, SSVF cannot assist those who were dishonorably discharged)

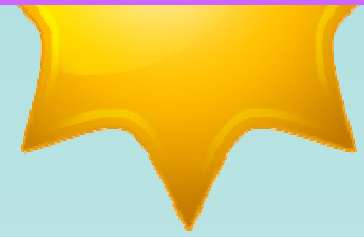
